Entries 2024: is a package per horse that includes a box in the outdoor stable* for 6 days (from Wednesday,23 to Monday,28), with first bedding shavings (2 bales), the registration at the competition, and one dinner for the Saturday night gala.

Fixed price of the package = 570 €

HEALTH CONDITIONS

Inspection upon arrival

As part of health safety procedures, free and clinical examinations can be conducted on the arrival of the equines on the site of the 2024 Europe final of the Iberian Horse Masters.

Horses must be in a good overall condition and each of the elements listed below must also be presented. If the clinical examination is debatable, the animal/horse may be placed in quarantine stables that are situated outside the exhibition, and in more severe cases, the horse will be refused admission to the exhibition.

Veterinarians and the Organising Committee reserve the right to exclude any horse which does not meet these Conditions

Vaccination regulations:

A valid overview of the mandatory vaccinations against influenza must be registered on the page "Influenza vaccinations" in the horse passport and all other vaccinations administered to the horse must be listed on the page "Other vaccinations".

Equine flu vaccination is mandatory: the "vaccination" sheet should include a stamp from veterinarian.

For horses born before 1 January 2022, the basic vaccination against influenza must consist of two vaccinations, which must have been administered at least 21 and at most 92 days apart. The horse may not be entered into competitions in the period between these two vaccinations.

- Primary vaccination comprising two injections of flu vaccine separated by an interval between 21 and 92 days;
- Booster to be administered 5 months later: the interval between two injections must not exceed 6 months;
- For the annual booster, the interval between two injections must not exceed twelve months.

A vaccination must have been administered at least seven days before the (first) competition (day). It is not permitted to bring the horse in question to competitions during these seven days

Mandatory elements

For all horses

- **The identification papers with the description** noted by an official veterinarian or a studbook agent or provisional certificate for those waiting for the definitive description of the studbook.
- **An electronic transponder.**
- For professional transporters: Type 2* certificate and Certificate of competence
- **A health certificate** from the licensed veterinarian of the departure farm stating that the horses or equine species being exhibited have been free for at least 30 days from clinical signs of any infectious disease.

Horses from foreign countries

- A copy of the pedigree and zootechnical certificate issued by the country of origin and endorsed by the authorities (

⇒ **Intra EEC:** Certificate from the TRACE NT system : In order to comply with the new European Standards, we thank you for bringing a Health certificate established "TRACE NT" for your arrival with your horses. Before departure you must contact the Health Authorities in your country of residence in order to obtain the "TRACE NT certificate"
